## Describe in as much detail and correctly as possible the following data:

- 1. Details of the subject matter of the intellectual property right in respect of which the infringement occurred (hereinafter, the **«Subject»**):
- 1.1. Name of the Object;
- 1.2. The official page of the Object / other sources of information about the Object on the Internet (if any);
- 1.3. Documents confirming the intellectual rights to the Object (if any).
- 2. Information about the rightsholder:
- 2.1. Passport details of an individual/full name, Individual Taxpayer Number, Primary State Registration Number of the legal entity;
- 2.2. Postal address and legal address;
- 2.3. Website / other resources of the right holder on the Internet (if available);
- 2.4. License for the right of activity (if such activity is legally licensed);
- 2.5. Contact person of the right holder (name, position, telephone number, e-mail).
- 3. Data of the person filing the complaint:
- 3.1. Full name;
- 3.2. Position, if a person files a complaint in defense of someone else's rights;
- 3.3. Telephone number;
- 3.4. E-mail:
- 3.5. Copy of power of attorney to act on behalf of the right holder (not required if the person filing the complaint is the head of the right holder's company) if the person is filing a complaint in defense of someone else's rights.
- 4. Data on the fact of infringement of the intellectual right to the Object.
- 4.1. The address of the resource page that contains your infringing data. The link must have the form <a href="http://www.oskelly.co/XXXXX">http://www.oskelly.co/XXXXX</a>
- 4.2. Full description of the essence of the violation of the rights (what the violation is, why dissemination of this information is prohibited by the right holder).
